

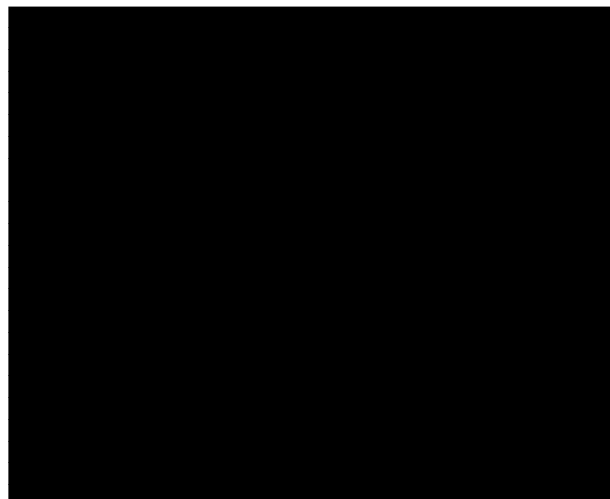
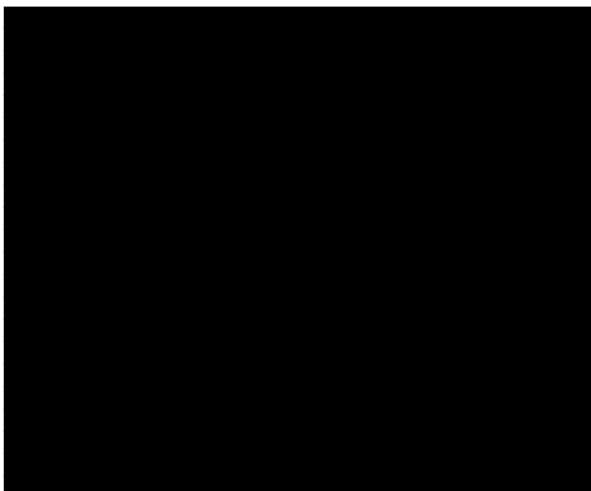
**Statement by Jxxxx Lxxxx-Wxxxxxxx – April 12, 2014**  
**D.O.B. Aug 1, 2000**

I, the undersigned, Jxxxx Lxxxx-Wxxxxxxx state the following to be the truth:

- 1) I am writing this statement to supplement previous statements I have signed in my efforts to get out of the care of the Children's Aid Society (CAS) and to get back home with my family. My family has a good home for me to go back to.
- 2) I am currently 13 years of age and am still being forced to live in foster care under the control of the CAS against my wishes. I do not suffer from any mental conditions which prevent me from fully understanding the contents of this document and the circumstances which affect me.
- 3) I currently live in a CAS foster home in Angus, Ontario with CAS foster parents Dxxx and Jxxxx Sxxxxxxxxxxx.
- 4) I have signed previous statements on July 20, 2013 and December 15, 2013, copies of which are attached and previously given to the Children's Aid Society.

**Attached to this statement are my two previous statements which I signed on July 20, 2013 and December 15, 2013.**

- 5) It has been more than two years since I have been telling the CAS workers that I want to leave foster care and to return home to my own family and to be with my younger brother Txxxx.
- 6) The CAS workers will not give me any answers nor give me any reasons why I cannot return home to my family. I have been in foster care for too many years and there is simply no reason for me to be in care any longer when I have a caring family to return home to.
- 7) Below are photos taken of me with my family taken a few months ago at Walmart. The photo on the left is my younger brother and I with our stepfather Rxx and the photo on the right is with my mother, Cxxxxx Lxxxx.



- 8) My stepfather, Rxx is retired from the Canadian Armed Forces just this past February. Below is photo of my brother Txxxx and I with Rxx on Remembrance Day and a picture taken today on April 12, 2014 at my parents home in Pembroke, Ontario.

- 9) As I have stated so many times it is my wish and preference to be taken out of foster care and returned to the home of my mother and stepfather who live in Pembroke, Ontario, where I feel safe and where it is my real home. I have friends in Pembroke as well. I should have been moved back to Pembroke last year but here it is April of 2014 and CAS workers still won't give me any answers.
- 10) I have been saying for years now that I am not happy living in care of the CAS in Angus, Ontario. I have not been happy since being moved by the CAS to Angus, Ontario which is about a 5 hour drive away from my mother, Rxx and my younger brother Txxxx. Each month my CAS foster parents drive me 5 hours each way for a weekend visit. The trip is long, boring and tiring.
- 11) I am not happy being separated from my brother and unable to see him more often and feel that our relationship as brothers will be better if we both live together with our families in Pembroke. As brothers we should grow up together.
- 12) I have not heard from my children's lawyer for a long time and I don't even know if she still is working for me. Even after I signed a statement last December my children's lawyer did not contact me. Nobody, including my children's lawyer has told me if I still have a lawyer or not. I am upset that nobody from the CAS listens to or respects my reasonable wishes and preferences.

- 13) I have signed this statement of my own free will. Just as I indicated in my previous statements, I simply want to get out of the care of the CAS and to go back home to live with my family back in Pembroke, Ontario at the end of this school year. I do not want to live with my foster parents anymore when I have my family who I want to come home to. I have wanted to come back home for years now.

### **My immediate wishes**

- 14) The following are my reasonable wishes:
- I wish that the CAS workers would arrange to have me returned to my family this June after I am finished my current school year.
  - I wish that the CAS workers would stop refusing to speak with and communicate with Mr. Beck whom I have asked to support and advocate for me.
  - I wish to be able to speak freely to anyone I trust when I am at my foster home without the fear of my phone calls being blocked or interfered with.

### **My consent and acknowledgement**

- 15) Below is a photo of me captured from the computer during a live video interview on Skype with Mr. Beck from Canada Court Watch on Saturday April 12, 2014 at about 9:30 AM. I was alone at my parent's home in Pembroke, Ontario when this live video interview occurred. Mr. Beck from Canada Court Watch is shown on the bottom right side of the photo below.



- 16) I acknowledge that no one has put pressure on me to sign this document and I am signing this statement of my own free will. I fully understand the contents of this document and give my informed consent to this document being shared with anyone.
- 17) I give my consent to the CAS workers, to my children's lawyer and to anyone involved in my family matter to speak with and to exchange any and all information with Mr. Vernon Beck which pertains to me and my involvement with the CAS. I give my consent for this document to be used in any way to advocate for my freedom from the CAS.

18) I give my consent for anyone who would like to speak to me, including any judge, by phone or by video conferencing on Skype should they wish to speak to me in person to confirm my identity and/or to confirm the accuracy and truthfulness of the contents of this document.
