## Should homosexual partners be able to adopt?

In the United States only 11 states allow same-sex marriage. Most do not because our government is generally based off of religion and the Bible. When a bill to introduce the possibility of homosexuals adopting was put into congress, it was almost immediately disapproved. According to the Wisconsin law, the only adults who can adopt are unmarried adults or a husband and wife married under law. Adoption by same-sex couples is prohibited by a majority of countries as well. Though homosexual adoption is only legal in 11 states in the U.S, many Christian activists are trying to change that.

In all cases, same-sex partners adopting children robs children of the potential of growing up with a traditional family consisting of a mom and a dad. A child needs to grow up with two different gendered

parents so they experience both qualities that God bestowed on a mother and a father, a man and a woman. Studies demonstrate that there is, in fact, a difference between non-heterosexual and heterosexual parenting. Children raised by non-heterosexual parents are placed at risk of many different things. A child adopted into homosexuality will get confused because everyone else will have two different-gendered parents that can give them the correct amount of motherly nurturing and fatherly structure necessary for raising a child. According to The Week Magazine, boys without fathers underachieve, especially since there are now fewer male teachers in primary schools. According to administrators at the Evan B. Donaldson Adoption Institute; "Laws and policies that prevent adoption by gay or lesbian parents disadvantage the tens of thousands of children mired in the foster care system that need permanent, loving homes."

Speaking of, there are over 163 million orphans in the world. There are 60.3 million married couples in the US alone. Out of those couples most of them have children of their own, or chose not to have children. Currently in America, there are 520,000 unfortunate children in the foster care system. According to the North American Council on Adoptable

Children, of those in foster care, 120,000

are available for adoption, but only 50,000 find permanent homes each year. Which brings me to the real question, why then shouldn't homosexual couples in committed relationships, who pass the adoption agencies standards be legally able to adopt orphaned children?

Whether or not homosexuality is right or wrong, it is very present in society, and will not be disappearing anytime soon. That said, would society prefer to leave children without a home or bouncing around the foster care system rather than having them be nurtured and cared for in a stable home environment, even if they are being raised by a same-sex couple?

First, I would like to make clear that my stand-point on this issue is not about homosexuals, it is simply about meeting the needs of children. The very needs of children who are in dire need of a home, a family, and the chance for a good life. Although the country is split on whether or not homosexuals should legally be allowed to marry, most Americans agree that the fostercare system is not the ideal living situation. According to statistics by

the Foster Care Alumni, only 54 percent of children in the foster care system earned a high school diploma, and only 2 percent went on to college and earned a Bachelor's degree. 51 percent were reported unemployed, and 25 percent had been homeless. One of the main arguments against homosexual couples adopting or fostering children is that the parent's homosexuality will influence their children's upbringing and also affect their sexual orientation. All of the research to date has reached the same indisputable conclusion about gay parenting: the children of lesbian and gay parents grow up as successfully as the children of heterosexual parents. In fact, not a single study has found the children of lesbian or gay parents to be disadvantaged because of their parents' sexual orientation.

According to an article in the International Adoption database, researchers wrote, "Good parenting is not influenced by sexual orientation. Rather, it is influenced most profoundly by a parent's ability to create a loving and nurturing home -- an ability that does not depend on whether a parent is gay or straight."

It is common knowledge that we as humans are all flawed; however, some are more flawed than others. How then, can members of American society sit back and judge whether or not someone is a suitable parent simply by their sexual orientation? Shouldn't we leave such an important decision up to professionals who scrutinize the couple, based on numerous characteristics, not just one-narrow minded one such as sexuality? Whether or not homosexuality is morally correct, homosexuals are human beings, who are as compassionate, caring and suitable parents as heterosexuals.
