Further to our telephone discussion of April 7, 2005, we confirm that our client obtained an Order compelling your Blogger member, "babytameron" also known as [REDACTED] to delete certain defamatory material from the above-noted internet site and also restraining her from posting further defamatory material regarding our clients. Please find enclosed a copy of the Order of the Honourable Mr. Justice R. Gates dated April 5, 2005. You will note from the Order the following:

1. Justice Gates determined that the words and statements set out in Schedule "A" of the Order were libellous and defamatory and therefore ordered [REDACTED] to remove, delete and/or expunge same from the above-noted internet site. Schedule "A" to the Order is a copy of the website printed on February 23, 2005. The words and/or statements that were ordered deleted have been literally crossed-out on the printout of the internet site dated February 23, 2005.
2. Justice Gates ordered that the postings of March 11, 2005 at 11:46 a.m., March 14, 2005 at 1:08 p.m. and March 18, 2005 at 7:15 p.m. be deleted from the internet site in their entirety;
3. Justice Gates ordered that the title of the website, <http://caskidnappers.blogspot.com>, be renamed without reference to "cas";
4. Justice Gates further ordered that [REDACTED] be restrained from broadcasting, posting or issuing any libellous or defamatory statement regarding Chatham-Kent Integrated Children's Service, Sandra Pepper, Robert Fellows and Karrie Spotten until the final disposition of the action.

We confirm your earlier advice that Google will abide by an Ontario Order that determines that the impugned content on the internet site is defamatory and/or requires [REDACTED] to delete same and that Google will take appropriate steps to complete the terms of the Order. As such, we trust that you will take the appropriate steps to have the defamatory words, statements and postings removed from the above-noted internet site, as set out in Justice Gates' Order, as soon as possible. We thank you for your assistance and if you should have any questions, please do not hesitate to contact the undersigned.



Party, acting in person, *failing to appear, although personally served, having been granted 1 week to file responding motion and not having answered when her name was read for this proceeding;*



THIS COURT ORDERS AND ADJUDGES that such words and statements as are struck out in the attached Schedule "A" are libelous and defamatory and hereby orders that the Responding Party, Nicole Mungar, shall remove, delete and/or expunge from the internet website <http://caskidnappers.blogspot.com> such words as are struck out from the attached Schedule "A" and the broadcasts dated March 11, 2005 at 11:46 a.m., March 14, 2005 at 1:08 p.m. and March 18, 2005 at 7:51 p.m. in their entirety, forthwith.
2. THIS COURT ORDERS that the Responding Party, Nicole Mungar, shall rename the internet website <http://caskidnappers.blogspot.com> without reference to the Moving Parties, "CAS", "Children's Aid Society" and/or any defamatory statements.
3. THIS COURT ORDERS that the Responding Party, Nicole Mungar, or any person acting under the direction of the Responding Party, Nicole Mungar, shall be and are hereby restrained from broadcasting, posting, issuing or in any way disseminating libelous or defamatory statements regarding the Moving Parties, Chatham-Kent Integrated Children's Service, Sandra Pepper, Robert Fellows and Karrie Spotten, or any employee(s) of the Moving Party, Chatham-Kent Integrated Children's Service, until trial or final disposition of this action.

4. THIS COURT ORDERS that costs of this Motion shall be and are hereby fixed in the sum of \$2,000.00 plus GST of \$140.00.

My Complaint is:

- I have been involved with ~~Sandra Pepper of the Chatham Kent Integrated Children's Services. Children's Aid Society~~ since approximately 2003. Since that time I have spoken to her and her Supervisor, ~~Rob Fellows~~, about wanting a new Worker. Each time I was refused.
- ~~Sandra Pepper has been stalking me and criminally Harassing me.~~ There was one occasion that she admitted watching me as I was walking down the road. She attended a personal matter that I was involved in twice, without my consent. She contacted my Boyfriends Probation Office about him and discussed my personal details, even though I am not and have never been involved with Probation. She did this without a Signed Consent from either of us. She disclosed my Source of Income to his Probation Officer and faxed her a Copy of my Court Affidavit, breaching my Confidentiality.
- Despite information that stated otherwise, she has taken my son from the Hospital, and refused any cooperation with us. She changes information to suit her own purposes, which is to place my son for Adoption in order to gain government funding.
- She also has certain workers write reports to go along with her false stories.
- She has requested non-relevant information of us in an attempt to discriminate, as she already has, information such as wanting to know how much our Internet costs and how much we spend on smokes, as well as how much money we get.
- ~~Sandra Pepper~~ is trying to "Make a case as she goes along", not basing her actions on fact but on fictions made up.
- ~~Sandra Pepper~~ has not attempted to work with us, rather, took our newborn baby from the hospital and placed him in an Adoptive Foster Home. As well, this is my boyfriend's first biological child and yet ~~Ms. Pepper~~ wants to get Crown Wardship.
- I would also like to mention that ~~she previously stole another child of mine~~, and pulled the same power trip, laughed and joked about the

whole thing.

- She also came to my house and announced on two occasions, one in front of my company and the other time on my step in front of the neighbors, that we had contracted an S.T.D.

I am certain there is more that I have forgotten, however, I am quite upset today and if I remember anything else I will let you know.

I look forward to hearing from you regarding this at your earliest convenience.

Thoughts....

It is 5:18 am. I can't sleep, too many thoughts in my head, mainly the Court Cases surrounding my older boys. I did some dishes but the thoughts are still there.

I want to get my Court File from Newfoundland because as far as I can recall I was never served any papers from the Children's Aid Society, no Affidavits, nothing.

I don't recall doing an Affidavit or reply, or ever signing one that a lawyer may have done.

For what its worth, we did have a trial but that was an injustice and did not cover the facts. Technically, in regards to documentation I believe I was screwed. And many others as well.

So now I have to contact Legal Aid in Newfoundland and try get this information. If I am correct as far as my memory goes there is going to be one hell of a Lawsuit.

My mind is working overtime and no wonder. Why is it that I am the only person who feels screwed by the System. Everyone has the right to a Fair Trial but what is fair about arguing a defense when you don't even know what the Charges are or when the Charges are Bogus?

Or when the Charges are based on a Concern that "There was too much Conversation, therefore we put our needs above our son's"? Bogus Bullshit.

My Concern is that the note takers spend more time talking about their Tim Horton's Coffee, Kids, Houses and new Rings than writing accurate facts. As well, if they write something good all ~~SANDRA PEPPER~~ sees is that we talked too much, we are slandering the Society Workers.

~~Screw you SANDY, You slander us and other good people every day. If you can give it, you can take it. At least my accusations are based on fact, not based on millions of dollars funding from the Government. I~~

~~will always be a Mother, not for the basis of money, for the basis that I am and that I love and care for my children. You may not always be a Worker. You do not love your job, you love the money and the status. Once the money is gone, so are you and you know it. You always talk about how you have Seniority in your office. Why? Because you lie about more people to get their kids than others do? Because you won bitchiest worker of the year award? Biggest Office Liar? Do you want a Medal? A Certificate?~~

I am sure its not all your fault though right? I mean you tell us that everything goes through your Supervisor, ~~ROB FELLOWS~~. Until we speak with him and he says it you of course. Typical Worker, Pass the Blame.

And then you say that we Pass the Blame. WE Take Responsibility for our Actions ~~SANDY~~. WE give Credit where Credit is due. You however do not.

We get good reports from the Access Center so you say we are Flight Risks. Tell me ~~SANDY~~, if I was really a Flight Risk, Don't you think I would have ran when I was Pregnant rather than inviting you into my home in an attempt to co-operate with you? You claim that I don't get enough money from ODSP to support my son and want to know how much we get. Tell me ~~SANDY~~, If I can't afford to support my son, How the Hell do you expect that I am a Flight Risk? Do you think I am just going to say "Go-go Gadget Shoes" and lift off into the sky and have a little propellor fly out of my hat and whisk us off to a deserted island in no-where land? Go Figure.

If you think that you are more crazy than I thought.

I also found out some information for my arguement on the 11th, in regards to The Children's Aid Act, The Mental Health Act and Legal Privilege. As well the fact that unless a person is found to be incompetant, anything from their Health Records or Assessments etc cannot be stated in Court. So screw you ~~SANDY~~, I am doing a better job as my own Lawyer, and I am going to argue you until the day I die. And I have enough Fight in me right now to go for quite some time.

are good and in our favor.

What a Surprise! Not! She has never said anything good about us. When we do co-operate then she says we are un-cooperative and a "Flight Risk". Because the Judge JUSTICE GLENN, has stated that in order for our son to come home there has to be alot of co-operation with the Society, and so SANDRA PEPPER keeps saying there is none just so she can get what she wants.

~~The only NON-COOPERATION is from SANDRA PEPPER and in the fact that her "Adoptive Foster Parents" want our son. That provides not only the Department with their extra funding but Foster Parents and Adoptive Parents now also get EXTRA FUNDING and TAX BREAKS for Adopting a Child through the Children's Aid Society. They don't want a baby for the fact of wanting to love and nurture a child, they want him on the basis of funding and the idea sickens me.~~

If the Government cut off the extra fundings to not just the Society but to Foster/Adoptive Parents as well, there would be less children taken and less children adopted out because no-one would want them. Sad but True.

I am Angry....

Before I begin I would like to make note (not a note taker note lol) of a Site I came across of Interest. Dufferin VOCA aims to reform the Children's Aid Society (CAS) of Dufferin County Ontario. It is one of many sites I came across, one of the better ones and is in Ontario which is a bonus.

Anyways, my day. We went to our visit this morning. Another scam that will be misrepresented in Court of course. Again, a lack of supplies provided for our son, visit went well but somehow we got on the topic of Foster Parents (Yeah the subject they get so defensive about).

Of course I have been upset since yesterday so of course I give my two cents worth (based on fact of course) and the note taker ~~LIZ~~ got VERY UPSET, I mean seriously I think she has an anger problem, and as the workers would say if we reacted that way, I think she needs to go to Anger Management. ~~LIZ~~ of course is also a Foster Parent (Go Figure) and so therefore got very defensive and said that she would gladly not be there writing notes if all children could be home with their families, so I replied that it is a choice that she made, if she would be happy not to be here then she didn't have to have the job. And then I gave my factual account of Foster Parents and the

forbidden topic of money. ~~LIZ~~ totally freaked, angrily, saying that she resented that, that SHE does not do it for the money that it goes back to the kids and that I was being very disrespectful (And I should respect you why?). I mean this is one of the worst note takers there. She is one of two of them who more than exaggerate facts. I was starting to worry about her reaction as she did seem very angry to me and then she left, locked herself in the staff office, and I assume sulked.. while the worker that I like most took notes for her. However she did threaten me that she would end my visit.

Truth hurts doesn't it ~~LIZ~~?

Anyways I go to a Probation Appointment with my bf and I get the joy of attending the meeting. During which I find out that the worker ~~SANDRA PEPPER~~, without my consent (or his) gave My affadavit to the Probation Officer who I only met today. And also told the Probation Officer that my bf Violently Shook our son and yelled at him. I am so mad. First of all I have a signed letter from ~~SANDRA PEPPER~~ that states that she was told by a note taker that he gently shook him and spoke firmly to him. Secondly, the fact is that our son woke and we went to change him. He was crying because he just woke and was hungry and he was laying on the change table and my bf rubbed his little tummy and said his name, which has comforted him. This was misconstrued and of course is now being added to (~~Thank God I got that letter from SANDRA PEPPER~~). Anyways ~~SANDRA PEPPER~~ thought this meant he would suffer Shaken Baby Syndrome so I wrote her a letter explaining the situation and gave her current information on Shaken Baby Syndrome.

Anyways I have been doing more research since then, I am so angry. I am planning on *trying* to get a Peace Bond and have Criminal Harassment Charges against her. I also left a message for her Supervisor ~~ROB FELLOWS~~ and am Complaining and asking yet again for a change of workers. Printed a Copy of the Code of Ethics of Social Workers. Took some key info from the Children's Aid Act for Court. Yes I am angry. But I am not angry. It is productive anger and there is a difference.

PS Edited to add that ~~SANDRA PEPPER~~ also told the Probation my source of income and I believe they may have both contacted the ODSP Office Directly due to statements made by both of them.

That 44% of our Children are in Foster Care being placed for Adoption or forever stuck in the System of Lies.

~~We, as a Society, cannot allow our Government to steal our children. To sell them to the highest bidder in a "Legalized Black Market Adoption Scam".~~

~~I do not believe that Adoption is wrong, but when it involves the Kidnapping of our Precious Children, in order to do so and gain Government Funding then their is a Problem.~~

Ever wonder where your Hard Earned Tax Dollars go? Ask the Government to show you how much they pay the Children's Aid Society for the Children they kidnap. Ask to see the "Society's" books. Ask how much the Government pays the "Society" for every Child they Place in Care, and how much more they get for Adopting them out, severing the ties between them and their Families, their Real

My newborn son alone has 7 Plus Workers writing "notes" on him and "Monitoring his Care", yet the sub-standard care he is provided with is less than adequate and when we try complain nothing is done because, you know, the Foster/Adoptive Parents are good people monitored by the "note-takers", no lies made up about them, just us and other Families the "~~Society~~" is discriminating against.

So I sit here at my Computer on the Internet, which by the way, they want to know how much it costs me for the Internet because that may take away from my Money that I spend on my boy. As if!

I did some searching and E-mailed two Toronto Lawyers about a CLASS-ACTION LAWSUIT. My Legal Aid Appointment is tomorrow. Screw that! Legal Aid would not help back on December 13th 2004, when my baby son was born. Would not see me until Feb 1st 2005. I did my Answer and Reply and Affidavit myself. Argued in Court myself. Challenged the "~~Society~~" and their Lawyer. Served the Affidavits. Filed them. Filed my Motion to Change Access, which by the way is Monday to Friday for only two hours each day at the Access Center where Workers get paid to write more notes.

I am doing a better job defending myself than any Lawyer ever did. Like most recently when I was Pregnant and I was fighting to get my other son back who was Born Jan 11th 2004, and the Lawyer, PAUL WATSON, (Yeah I am not afraid to give names now, so sue me, I have proof) walked in to Court while I was home sick and agreed with the Crown against my wishes and signed over my other baby son to the ~~Society~~ for Adoption.

I saw a Young Mother at Court one day, one who goes to the Access Center and she was talking to PAUL WATSON, Poor girl doesn't realize she doesn't stand a Chance. A Work of warning, don't ever hire PAUL WATSON if you are in the Chatham Area or your Screwed, simply put. You will go through the Motions while PAUL WATSON rakes up the Legal Aid Funding, or your own, and subsequently makes sure you lose your Child(ren).

Just a warning.

So about my Class Action. It's like this. I will find a lawyer to help us. More-so in Ontario but also all over Canada because my personal vendetta also extends to the Newfoundland Children's Aid Society and certain Workers there, namely BRENDA BARRETT, who was in the Hr. Grace Department and subsequently, moved over to the Bay Roberts Office.

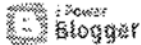
