
Barrie, Ontario Community Justice Awareness Event Friday, July 6, 2007 – 9:00 am (2nd Annual)

Every year in Ontario, thousands of Ontario children and their families are adversely affected and in many cases torn apart as a result of the draconian policies and procedures of the family courts and children's aid societies.

On Friday, July 6, 2006 Canada Court Watch will be organizing a public awareness campaign to help bring to the attention of the public, the plight of children and families being adversely affected by our family justice system and by many of the agencies associated with the family court system.



If you are a parent or a child who has been affected or a citizen who would like to assist your fellow Canadians to bring greater accountability and transparency to our family justice system, then we urge you to attend this event. This will be a good opportunity for individuals and families to network with others who have been similarly affected or who have similar interests.

Participants will distribute literature to members of the public at the local courthouse and throughout various retail and commercial areas throughout Barrie, Ontario. We will also make a surprise visit to the offices of the Simcoe County CAS in Barrie. Children are welcome to participate. In the afternoon there will be a barbecue at beautiful Centennial Park on the south side of Barrie for those who helped. There is a public swimming area and a playground for younger children. Free food and drinks will be provided to all those who participate in scheduled activities during the day.

Those who wish to participate should call us ahead of time and advise us so that we can schedule their participation with the group and to ensure that we can keep participants informed of any last minute changes. Food will be ordered for those who advise us that they are coming.

Accommodation

For those coming from out of town, there is camping and motels. There is some limited space at the homes of local members. Contact Court Watch if you want further information about accommodation in the area. A Thursday night get together will be planned if enough interest is expressed by those who may arrive in town the night before the event.

When and where to meet

Those who wish to arrive early will meet at Barrie's downtown McDonald's for breakfast between 7:30-9:00 am. Those who wish to arrive at 9:00 am can meet at the court house. For those who arrive after 10:00 am, you should sign in at the picnic shelter which is located at the beach which is on the south side of the City of Barrie on Lake Simcoe. Those who may already have Court Watch T shirts or hats are encouraged to wear them to the event.

Car pooling

To help participants reduce travel costs, we will help arrange car pools from different areas. If you would like to offer someone a ride or would like to get a ride with someone else, then please contact us and we will try to help you coordinate a ride with someone else in your area.


Where to park during the day

Parking is not a problem. There is free parking on the north side of the court house in Barrie. There is lots of parking at the public beach area where participants can register at the picnic shelter.

Directions to Barrie Court

From Highway 400 exit at Hwy 26/27. At the top of the ramp turn right on to BAYFIELD ST. Go about ½ mile and then turn left on WORSLEY ST. Court House is at 114 WORSLEY St. Total estimated time from Hwy 400: 5 minutes. There is lots of free parking on the north side of the courthouse. Look for a Court Watch representative near the entry to the courthouse. Participants will be in attendance at the courthouse from 9:00 am to approximately 2-3 pm only (barbeque after that time).

Directions to beach from courthouse (Rally registration location)

From the courthouse go WEST on WORSLEY ST toward MULCASTER ST. (0.1 miles). Then turn LEFT onto MULCASTER ST. Then turn RIGHT onto LAKESHORE DR. (0.6 miles). Then turn RIGHT onto VICTORIA ST. (0.1 miles) Park is at 11 Victoria Street Picnic shelter is almost opposite a small railroad caboose which is on your right side of the road. Total estimated time: 3 minutes. Check in at the picnic shelter where a Court Watch representative will be in attendance. **Alternate direct route:** From highway 400 go south on Bayfield to the very end of the street which is Lakeshore Dr.. Turn right, pass some new condo projects and watch for the picnic shelter which is on the opposite side of the road as the old railroad caboose.

Directions to McDonalds (Downtown Barrie)

From Highway 400 exit at the DUNLOP St. and go EAST on DUNLOP St.. The DUNLOP St. exit is one exit south of the BAYFIELD St. exit. Simply follow DUNLOP St, in an east direction to the McDonalds at 85 Dunlop Street. McDonald's is just a short distance to the court and the beach area. Participants will be at McDonalds for breakfast only from 7:30 am to 9:00 am on Friday August 25, 2006. If you miss McDonalds participants must go to the courthouse or to the beach at 10:00 am.
