CHALIFOUX, Misty Angela, 28, Driftpile

On January 20, 2006, Misty Chalifoux, Trista Chalifoux, Larissa Chalifoux, and Michelle Lisk were killed in a head-on collision with a vehicle engaged in a high speed pursuit with police.

S.M.**

On December 3, 2006, S.M. was transported to hospital after a period of illness. S.M. was born with Tetrasomy 18p (Isochromosome 18p), a rare chromosomal disorder.

SCHLOGEL, Erna, 92, Radway

On January, 24, 2007, Erna Schlogel died after having contracted a virus in her care centre.

ABSALIAMOVA, Jamillia, 51, Edmonton,

On November 14, 2007, Jamilia Absaliamova was admitted to hospital with abdominal pain. She was treated for bowel obstruction but died on November 15, 2007.

ROY, Dwayne Roger, 57, Edmonton

On July 30, 2007, Dwayne Roy was attacked by another patient in a hospital psychiatric unit.

ADOLF, Lorraine Julia, 68, Edmonton

On December 2, 2008, Loraine Adolf went missing from Alberta Hospitals Edmonton. She was found deceased in a secluded area on the property on December 11, 2008.

GRIMOLFSON, Trevor Ashley, 38, Edmonton

On October 29, 2008, Trevor Grimolfson was seen behaving in a violent, aggressive manner. During a struggle to restrain him he was electronically stunned by Police. He became unresponsive and attempts at resuscitation were unsuccessful.

BROCK, Kathleen, 75, Calgary

On July 24, 2008, Kathleen Brock suffered a head injury while being transported in a Handibus. She underwent surgery, however, her condition deteriorated and she died on August 7, 2008.

MACAULAY, Ronald Joseph, 50, Rocky Mountain House

On November 2, 2007, Joseph Macaulay was treated at hospital for alcohol intoxication. He was found unresponsive in the early morning of November 3, 2007.

BELLEROSE, Joseph Douglas, 35, Edmonton

On April 4, 2008, Joseph Bellerose was found unresponsive in his cell at the Edmonton Institution.

<p>VENESS, Matthew Jirsch, 25, Edmonton</p> <p>On November 16, 2008, Matthew Veness Matthew Veness was found in his cell at the Edmonton Institution with a self-inflicted neck wound. He was transported to hospital and underwent surgery, but died shortly after.</p>
<p>IVALL, Kevin Kenneth, 31, Canmore</p> <p>On June 14, 2008, Kevin Ivall was distraught and suicidal. Police attended and entered the residence after Mr. Ivall stopped communications. They deployed a distractionary device and entered the bathroom where he was barricaded. Mr. Ivall was found unresponsive due to self-inflicted ligature strangulation.</p>
<p>SMITHSON, Nathan, 31, Stony Plain</p> <p>On October 3, 2007, Nathan Smithson suffered a seizure in his home. His care provider called Emergency Services and he was transported to the hospital where he was pronounced dead.</p>
<p>LOUIS, Fong Sue, 77, Calgary</p> <p>On August 3, 2008, Fong Louis was found in her room at her long-term care facility. She had slipped through the restraints on her wheelchair and her neck was compressed by the belt.</p>
<p>MCKORT, Trevor Jeffrey, 37, Edmonton</p> <p>On August 1, 2008, Trevor McKort was found unresponsive in his cell at the Edmonton Remand Centre. The cause of death was determined to be acute morphine toxicity.</p>
<p>LARAMEE, Nicole Theresa, 27, Edmonton</p> <p>On January 14, 2009, Nicole Laramée was discovered unresponsive at Alberta Hospitals Edmonton after having strangled herself with a cloth. She was resuscitated but had suffered an anoxic brain injury and died January 15, 2009.</p>
<p>OMEASOO, Sylvester, 47, Hobemma</p> <p>On October 6, 2008, Sylvester Omeasoo was found unresponsive in his cell at the Wetaskiwin RCMP Detachment. The cause of death was determined to be ethanol toxicity.</p>
<p>CASELL, Colin, 31, Sylvan Lake</p> <p>On May 21, 2008, Colin Cassell underwent emergency neurosurgery after a CT scan revealed bleeding on his brain. His condition deteriorated and he died the same day. Colin had been detained in police custody and then assessed at hospital on May 8, 2008 after complaints of severe headache. He was discharged May 9, 2008.</p>
<p>MCALLISTER, Stewart James, 20, Medicine Hat</p> <p>On October 24, 2008, Stewart McAllister fell down a stairwell and sustained blunt cranial trauma. He was transported to hospital, but died on October 29, 2008.</p>
<p>BOWE, Gordon Walker, 30, Calgary</p> <p>ON November 1, 2008, Gordon Bowe became unresponsive after being retrained as a result of an altercation with police members. He was transported to hospital and died on November 2, 2008.</p>

<p>POULIN, Leo Raymond, 59, Vegreville</p> <p>On July 12, 2008, Leo Poulin advanced police officers and pointed a shotgun. After refusing orders to drop his weapon, he was shot.</p>
<p>TOEWS, Ashish, 33, Calgary</p> <p>On July 18, 2008, Ashish Toews underwent abdominoplasty with liposuction at a private clinic and was released. On July 19, 2008, she was admitted to hospital with complications. Her condition deteriorated and she died on July 31, 2008.</p>
<p>MAYOR, Weldon Scott, 77, Calgary</p> <p>On November 4, 2008, Weldon Mayor had a fall at the hospital and suffered head trauma. His condition deteriorated and he died on November 12, 2008.</p>
<p>TONEY, Janessa Lyn, 5, Chestermere</p> <p>On September 28, 2008, Janessa Toney was found unresponsive beneath a capsized boat following an emergency rescue on Lake Newell.</p>
<p>J.L. **</p> <p>On April 16, 2008, the newborn body of J.L. was found wrapped in a towel in a wooded area outside of Stony Plain.</p>
<p>LECAVALIER, Lucy, 93, Edmonton</p> <p>On September 24, 2008, Lucy Lecavalier was mistakenly administered a lethal dose of medication at her long-term care centre. She was transported to hospital, but despite treatment she was pronounced dead the same day.</p>
<p>MOUNTAIN, Kory Stewart, 40, Drumheller</p> <p>On December 2, 2008, Kory Mountain was found unresponsive in his cell at the Drumheller Institution. The cause of death was determined to be combined drug toxicity.</p>
<p>MOORE, Gene Elliott, 33, Calgary</p> <p>On December 13, 2008, Gene Moore was found in his cell at the Calgary Remand Centre with a self inflicted wound. He was given medical assistance but died the same day.</p>
<p>NEATE, Jason Dean, 19, Edmonton</p> <p>On January 14, 2009, Jason Neate was observed at the bottom of a pool moments after being observed swimming by lifeguards. He was transported to hospital where he died the next day.</p>

ORPEN, Albert Daniel, 90, Calgary

On August 23, 2009, 90-year-old Albert Orpen was being lifted with a mechanical lift at his care centre when he slipped out of the lift and fell head first, striking his head on the foot of the lift. He was transported by ambulance to hospital where it was determined he was bleeding on the brain. He died on August 30, 2009.

J.B. & J.B. **

On September 27, 2009, J.B. & J.B. were found unresponsive in a barricaded, sealed bedroom, with a cylinder of carbon monoxide gas.
