AND FOR THE SAID CONSIDERATION the Releasors represent and warrants that the Releasors have not assigned to any person or corporation any of the claims, debts, demands, actions or causes of action released or referred to in the said action.

IT IS UNDERSTOOD AND AGREED that the said payment or promise of payment is deemed to be no admission whatsoever of liability on the part of the Releasee.

WHEREVER the words "Releasee(s)" or "Releasor(s)" are used, they shall include the heirs, executors, administrators, successors, agents and assigns and this Release shall bind them or enure to their benefit, whichever the case may be.
