Dear Mr. Carter:

On January 10, 2013, the ministry received a Notice of Mediation from the Office of the Information and Privacy Commissioner of Ontario concerning the above-noted Freedom of Information Appeal.

Since that time, the ministry has had several discussions on the scope and specifics of this appeal with the assigned Mediator, Ms. Andrea Schwartz. Ms. Schwartz asked the ministry to review exemptions we had applied under Section 21 of the Act to the record disclosed to you on November 14, 2012 (Bibliography, pages 72 and 73). The exemptions related to the personal information of individuals named in litigation or in inquests.

The ministry has reviewed its application of Section 21 to the exemptions in question. In doing so, the ministry has tried to determine whether the exempted information was already publicly available and thus could be disclosed without constituting an unjustified invasion of individuals' personal privacy.

First, the ministry has tried on several occasions to confirm if the disclosed record, which dates back to 1998, was publicly released along with the bibliography at that time. However, the ministry cannot definitively confirm that the disclosed record was publicly released in its entirety in 1998.

Second, the ministry has tried to determine whether the specific information it exempted is publicly available through other means. The ministry has conducted searches through the Canadian Legal Information Institute website, as well as a general Google search, for the information exempted in each case.

Through these searches, the ministry has confirmed that information related to one case previously exempted is publicly available. As such, the ministry is enclosing a revised copy of page 73 of the records for you.
