AMALGAMATION AGREEMENT

This Agreement dated the 17th day of January, 2013

BETWEEN:

HIGHLAND SHORES CHILDREN'S AID SOCIETY

(Hereainfter "HSCAS");

AND

THE CHILDREN'S AID SOCIETY OF THE COUNTY OF PRINCE EDWARD

(Hereainfter "CASPE");

WHEREAS HSCAS and CASPE are corporations incorporated and existing under the *Corporations Act* of Ontario;

AND WHEREAS HSCAS and CASPE acting under authority contained in the said Act have agreed to amalgamate upon the terms and conditions hereinafter set out:

AND WHEREAS HSCAS and CASPE have each made full disclosure to the other of their respective assets and liabilities;

AND WHEREAS it is desirable that the said amalgamation should be effected:

In consideration of the mutual covenants and agreements hereinafter set forth, the parties agree as follows:

- In this amalgamation agreement, "Amalgamated Corporation" means the corporation continuing from the amalgamation of HSCAS and CASPE.
- 2. HSCAS and CASPE hereby agree to amalgamate under the provisions of Section 113 of the *Corporations Act* and to continue as one corporation under the terms and conditions hereinafter set out.
- 3. The name of the Amalgamated Corporation shall be **Highland Shores Children's Aid Society.**

- 4. The By-Laws of the Amalgamated Corporation shall not be the by-laws of either of the Amalgamating Corporations, but shall be enacted by the Amalgamated Corporation on or after the effective date. The by-laws of the Amalgamated Corporation shall be a form of general by-law made pursuant to the Corporations Act, approved by the directors and members of the Amalgamated Corporation.
- 5. The objects of Highland Shores Children's Aid Society shall be as follows:
 - (a) To promote the welfare of children, youth and their families;
 - (b) To provide safe and nurturing care for children and youth under the Child and Family Services Act or any other Act;
 - (c) To provide guidance, counseling and other services to families for protecting children or for the prevention of circumstances requiring the protection of children, that lead to child abuse and neglect;
 - (d) To investigate allegations or evidence that children or youth may be in need of protection;
 - (e) To protect children and youth from abuse and neglect as provided under the Child and Family Services Act;
 - (f) To supervise children and youth assigned to its supervision under the Child and Family Services Act or any other Act;
 - (g) To improve the home life of children and youth through counselling, treatment programs, other support services and by facilitating referrals to other community service providers;
 - (h) To arrange for and provide foster parents, foster care and foster homes for children and youth;
 - (i) To arrange for and provide Kinship homes, Kinship service and Kinship care for children and youth;
 - (j) To arrange for adoptive homes and place children and youth for adoption and provide post-adoption support;
 - (k) To operate or secure non profit residential accommodation and incidental facilities exclusively for children and youth primarily of low or modest income; and
 - (I) To work in partnership with aboriginal Native (First Nations) communities in providing services to aboriginal Native (First Nations) children and families.

Special Provisions

- (a) The Amalgamated Corporation shall be carried on without the purpose of gain for its members and any profits or other accretions to the Amalgamated Corporation shall be used in promoting its objects.
- (b) The Corporation shall be subject to the Charities Accounting Act.

- (c) The directors shall serve as such without remuneration and no director shall directly or indirectly receive any profit from their positions as such, provided that directors may be paid reasonable expenses incurred by them in the performance of their duties.
- (d) The borrowing power of the Amalgamated Corporation pursuant to any by-law passed and confirmed in accordance with section 59 of the *Corporations Act* shall be limited to borrowing money for current operating expenses, provided that the borrowing power of the Amalgamated Corporation shall not be so limited if it borrows on the security of real or personal property.
- (e) If it is made to appear to the satisfaction of the Minister, upon report of the Public Guardian and Trustee, that the Amalgamated Corporation has falled to comply with any of the provisions of the Charities Accounting Act, the Minister may authorize an inquiry for the purpose of determining whether or not there is sufficient cause for the Lieutenant Governor to make an order under subsection 317(1) of the Corporations Act to cancel the letters patent of the Amalgamated Corporation and declare them to be dissolved.
- (f) Upon the dissolution of the Amalgamated Corporation and after payment of all deuts and liabilities, its remaining property shall be distributed or disposed of to charities registered under the *Income Tax Act* (Canada), in Canada.
- (g) To invest the funds of the Amalgamated Corporation pursuant to the Trustee Act.
- (h) For the above objects, and as incidental and ancillary thereto, to exercise any of the powers as prescribed by the *Corporations Act*, or by any other statutes or laws from time to time applicable, except where such power is limited by these letters patent or the statute or common law relating to charities.
- 6. All funds and other property held by the amalgamating corporations immediately before the Letters Patent of Amalgamation become effective or at any time thereafter received by the amalgamated corporation pursuant to any Will, deed or other instrument made before the Letters Patent of Amalgamation become effective, together with all income thereon and accretions thereto shall be applied only to the objects of the respective amalgamating corporation as they are immediately before the Letters Patent of Amalgamation become effective.
- 7. The Amalgamated Corporation shall be a corporation without share capital.
- 8. The head office of the Amalgamated Corporation shall be in the City of Belleville in the County of Hastings, in the Province of Ontario.
